

**FANDANGO'S THE FRONTIER PASS SWEEPSTAKES**  
**OFFICIAL RULES (“Official Rules”)**

**NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**BY SUBMITTING AN ENTRY TO THIS SWEEPSTAKES DURING THE SWEEPSTAKES PERIOD, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT. SO READ THEM CAREFULLY BEFORE ENTERING. AMONG OTHER THINGS, THIS CONTRACT INCLUDES INDEMNITIES FROM YOU TO THE RELEASED ENTITIES AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.**

**ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. THE SWEEPSTAKES IS ONLY OPEN TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND DISTRICT OF COLUMBIA, WHO ARE 18 YEARS OF AGE OR OLDER. VOID WHERE PROHIBITED BY LAW OR RESTRICTED BY LAW.**

**SWEEPSTAKES PERIOD:** Fandango’s The Frontier Pass Sweepstakes (the “Sweepstakes”) begins at 12:00 PM Pacific Time (“PT”) on June 12, 2024, and ends at 11:59 PM PT on July 15, 2024 (the “Sweepstakes Period”). The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participants (“Participants”) agree to be bound by these Official Rules and the decisions of Fandango Media, LLC (“Sponsor”), which are binding and final on matters relating to this Sweepstakes.

**ELIGIBILITY:** Sweepstakes is open only to (i) legal residents of the fifty (50) United States and District of Columbia (excluding residents of Puerto Rico or other U.S. Territories) (the “Eligibility Area”), (ii) who enter the Sweepstakes from within the Eligibility Area, and (iii) who are at least eighteen (18) years of age or the age of majority in their state of primary residence (whichever is older) at time of Sweepstakes Entry (as defined below). Employees, officers and representatives of the Sponsor, Southern Made Services, LLC (the “Administrator”), and Warner Bros. Entertainment Inc. (“Warner Bros.”) and each of their respective parents, affiliates, subsidiaries, sales representatives, web-design, advertising, marketing, fulfillment, judging and promotion agencies, or other agencies involved in the administration, development, fulfillment and execution of this Sweepstakes, and each of their respective immediate family members or household members are not eligible to participate in the Sweepstakes. “Immediate family members” shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, and their respective spouses. “Household members” shall mean people who share the same residence at least three (3) months a year, whether or not related. Winning the Prize is contingent on fulfilling all requirements in these Official Rules. All federal, state, and local laws and regulations apply. Void where prohibited or restricted. All Sweepstakes Entries are the property of the Sponsor.

**HOW TO PARTICIPATE:** During the Sweepstakes Period, there are three (3) ways to participate. **1) Frontier Pass Entry:** To receive one (1) entry in the Sweepstakes (“Sweepstakes Entry”), opt-in to Frontier Pass at [www.fandango.com/frontierpass](http://www.fandango.com/frontierpass) to receive email updates and

content leading up to the releases of *Horizon: An American Saga – Chapter 1* (“Chapter 1”) and *Horizon: An American Saga – Chapter 2*. **2) Entry with Purchase**: To receive one (1) Sweepstakes Entry, opt-in (or be already opted-in) to Frontier Pass, and then purchase at least one (1) ticket during the Sweepstakes Period on [www.fandango.com](http://www.fandango.com) (“Website”) or the Fandango app (“App”) to see Chapter 1. You will receive one (1) Sweepstakes Entry after your ticket has been purchased. **3) Alternate Means of Entry**: To receive two (2) Sweepstakes Entries without making a purchase or signing up for Frontier Pass (each, an “AMOE Entry”), visit [www.fandangofrontierpassssweepstakesentry.com](http://www.fandangofrontierpassssweepstakesentry.com) and enter your full name, complete address (no P.O. boxes permitted), phone number (including area code), and email address during the Sweepstakes Period.

Sweepstakes Entries generated by script, macro or other automated means, and Sweepstakes Entries by any means which subvert the entry process, are void. By submitting a Sweepstakes Entry, you agree to these Official Rules and are willing provide your information to the Sponsor and the Administrator. Sweepstakes Entries become the property of the Sponsor and will not be returned.

There is a limit of two (2) Sweepstakes Entries per person, regardless of entry method, using only one (1) email address. Entries received from any person in excess of the stated limitation, or which are incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost or misdirected, will be void. Subsequent attempts made by the same individual to submit multiple Entries by using multiple or false contact information or otherwise may be disqualified.

Any and all information provided in connection with this Sweepstakes is subject to the Sponsor's Privacy Policy available at [www.fandango.com/terms-and-policies](http://www.fandango.com/terms-and-policies). By entering in the Sweepstakes, Participants hereby agree that the Sponsor may collect and use their personal information submitted with their Sweepstakes Entry. Among other things, the information Participants provide may be used to send company updates and announcements from the Sponsor concerning the company and its products. At the time of entry, Participants may be given the opportunity to opt-in to receive further communications from the Sponsor. Participants are not required to opt-in and opting in will not improve your odds of winning.

**SWEEPSTAKES PRIZE DRAWING & WINNER NOTIFICATION**: Winner is subject to verification of eligibility requirements, including verification of age. The potential winners of the Grand Prize (defined below) and 1<sup>st</sup> Prizes (defined below, and together with the Grand Prize, the “Prizes”) are referred to herein as the “Winners”, and each, a “Winner”.

The potential Winners will be selected in a random drawing held on or about July 22, 2024. Winners will be contacted via email on or about July 22, 2024.

The potential Winners will each be required to acknowledge receipt of Winner notification within three (3) days and in addition, (i) Grand Prize Winner will need to execute and return an affidavit of eligibility, a taxable income form, a liability release, and where lawful, a publicity release, all within three (3) days of date of issuance of such notification email, and (ii) 1<sup>st</sup> Prize Winners will need to provide their complete mailing address. If such documents or information are not returned within the specified time period, the Prize notification is returned as undeliverable, the

Sponsor or its agent is unable to contact a potential Winner, a potential Winner declines the Prize for any reason prior to award, or a potential Winner is not in compliance with these Official Rules, the Prize will be forfeited and, at the Sponsor's discretion, an alternate Winner may be selected. The Sponsor reserves the right not to award any Prize in the event the Sponsor is unable to identify and confirm a Winner after attempting to contact an alternate potential Winner. Sponsor is not responsible for any cancellations, delays, diversions, or substitutions, or any act or omission whatsoever with respect to any Prize.

Odds of winning will depend on the number of qualified Sweepstakes Entries received during the Sweepstakes Period.

**GRAND PRIZE (1):** There is one (1) grand prize ("Grand Prize") available to be awarded to one (1) Grand Prize Winner. Grand Prize Winner will receive a three (3) day, two (2) night trip for Grand Prize Winner and one (1) guest ("Guest") to meet Kevin Costner. The Grand Prize includes round trip coach class airfare for Grand Prize Winner and Guest to and from a U.S. major gateway airport near the Grand Prize Winner's home and an airport near the location in the United States that is selected by Warner Bros. for the meeting; hotel ("Hotel") accommodations (one (1) room, double occupancy) for a two (2) night stay; and ground transportation (roundtrip between the Hotel and local airport near the Hotel and between the Hotel and meeting). **The Approximate Retail Value ("ARV") of the Grand Prize is \$3,000.** ARV is estimated for purposes of these Official Rules only.

**1<sup>ST</sup> PRIZE (5):** There are five (5) 1<sup>st</sup> prizes ("1<sup>st</sup> Prizes") available to be awarded to each of five (5) 1<sup>st</sup> Prize Winners. Each 1<sup>st</sup> Prize Winner will receive one (1) Green Mountain Coffee Roasters® prize pack inclusive of one (1) Keurig® K-Iced™ brewer, five (5) boxes of Green Mountain Coffee Roasters® Horizon Blend K-Cup® pods and five (5) boxes of Green Mountain Coffee Roasters® Mountainside Mocha K-Cup® pods (for a total of ten (10) boxes). ARV of each 1<sup>st</sup> Prize is \$250. **Total ARV of 1<sup>st</sup> Prizes is \$1,250.**

**ARV of all Prizes available in this Sweepstakes is \$4,250.**

**GRAND PRIZE CONDITIONS:** The appearance of Mr. Costner in connection with the Grand Prize is subject to his availability and is subject to cancellation at Warner Bros.' sole and absolute discretion. No compensation will be paid, nor will a substitute prize element be provided, in the event the meeting with Mr. Costner is cancelled, as this portion of the Grand Prize has no cash value. The travel dates for the Grand Prize are within July-December 2024. The travel period for the Grand Prize cannot be amended or extended other than by Sponsor. The Hotel will require a credit card pre-authorization or cash deposit to cover any incidentals. Grand Prize Winner and Guest must have and are responsible for valid government issued photo ID for travel. Grand Prize is for Grand Prize Winner and Guest and no additional family members or guests

are permitted in the Grand Prize. Once selected, Guest may not be changed. Airline tickets are non-refundable/non-transferable and are not valid for upgrades and/or frequent flyer miles. All airline tickets are subject to flight variation, work stoppages, and schedule or route changes. Sponsor reserves the right to structure travel route and select hotels in its sole and absolute discretion. The Grand Prize Winner will not receive cash or any other form of compensation if actual travel costs are less than the estimate made in these Official Rules. The roundtrip air transportation element of the Grand Prize begins and ends at the point of departure. The Grand Prize is subject to seat and hotel availability, as well as Sponsor's terms and conditions generally applicable thereto. If in the judgment of Sponsor air travel is not required due to Winner's proximity to the Grand Prize location, ground transportation will be substituted for roundtrip air travel at Sponsor's sole and absolute discretion. The difference in value will not be awarded to the Grand Prize Winner.

If a Grand Prize Winner elects to partake in any or all portions of his/her Grand Prize with no Guest, only the applicable portion of the Grand Prize will be awarded to Grand Prize Winner and any remainder of the Grand Prize will be forfeited and shall not be subject to further or alternative compensation. Guest must be eighteen (18) years of age and the age of majority in their state of residence (e.g., at least nineteen (19) in Alabama and Nebraska) as of the date of departure or Grand Prize Winner must be parent or guardian of Guest. Specific travel dates and arrangements are subject to travel restrictions. Reservations are subject to availability. The ARV of the Grand Prize set forth above represents the Sponsor's good faith determination of the maximum ARV thereof, and the actual fair market value, as ultimately determined by the Sponsor, cannot be challenged, or appealed. Grand Prize consists only of the elements expressly set forth above; no other elements or expenses (including, without limitation, insurance, unspecified meals, unspecified ground transportation, baggage, gratuities, incidentals, souvenirs, gasoline, car rental, etc.) are included in the Grand Prize and all such additional expenses are the sole responsibility of Grand Prize Winner. Once issued, travel tickets are nontransferable and may not be reissued. Open tickets may not be issued, and stopovers are not permitted. Travel arrangements must be made through Administrator. Sponsor will not replace any lost, mutilated, or stolen tickets. Sponsor reserves the right to substitute the Grand Prize or any element thereof for one of equal or greater value, provided, however, that the meeting with Mr. Costner shall not be substituted in the event the meeting must be cancelled.

Winners and Guest irrevocably waive all claims against the Released Parties (as defined below), and agree that the Released Parties will have no liability or responsibility for any Losses (as defined below) arising in connection with participation in this Sweepstakes or the Prizes, including, but not limited to personal injury, wrongful death, a potentially heightened risk of exposure to communicable diseases, viruses, bacteria or illnesses (including, without limitation, COVID-19) and the causes thereof, sickness arising as a result of Participant's participating in the Sweepstakes and related activities (e.g., travel), wherever, whenever or however the same

may occur. Grand Prize Winner and Guest must abide by all applicable federal, state, local and venue COVID-19 guidelines while traveling and in attendance at the Grand Prize's events. Grand Prize Winner and Guest fully understand that (a) the novel coronavirus SARS-CoV-2 and any resulting disease (together with any mutation, adaptation or variation thereof, "COVID-19") is extremely contagious and there is an inherent risk of exposure to COVID-19 in any place where people are or have been present; (b) no precautions, including any protocols that will be implemented from time to time by the Released Parties (collectively, the "Protocols"), can eliminate the risk of exposure to COVID-19; (c) while people of all ages and health conditions have been adversely affected by COVID-19, certain people have been identified by public health authorities as having greater risk based on age and/or underlying medical conditions; and (d) exposure to COVID-19 can result in being subject to quarantine requirements, illness, disability, other short-term and long-term health effects, and/or death, regardless of age or health condition. Grand Prize Winner and Guest travel at their own risk.

**PRIZE CONDITIONS:** Winners are responsible for all applicable federal, state, local sales and income taxes and any costs, expense(s) or fees whatsoever in connection with their Prize not specifically provided herein. In the event that, for reasons beyond their control and not related to the Winner, the Sponsor or independent third-party company is unable to award any Prize as described in these Official Rules (including if the designated Prize should become unavailable for any reason), the Sponsor will substitute the Prize with another prize of similar nature and equal or greater value at its sole discretion. The Prizes are non-assignable and non-transferable and are not redeemable for cash and no substitution will be made except as provided herein at the Sponsor's sole discretion. If a selected Winner is unable to accept a Prize in its entirety for any reason, the selected Winner will forfeit the Prize and the Prize may be awarded to an alternate Winner. All Sweepstakes Entries and potential Winners are subject to verification by the Sponsor and the Administrator, whose decisions are final and binding. No compensation will be paid in lieu of a Prize. Prizes will be awarded provided that a sufficient number of Entries are received, and the Prizes are claimed in accordance with the dates and times specified above.

1<sup>st</sup> Prizes will be mailed to the mailing address provided during Winner notification. 1<sup>st</sup> Prizes may take 8-10 weeks to arrive after Winner notification.

**GENERAL CONDITIONS:** Sweepstakes qualification is determined when a qualifying purchase is made on the Website or App, or when a Participant consents to opt-in to Fronter Pass, or when a request for an AMOE Entry has been submitted in accordance with these Official Rules. Proof of identity and/or residence reasonably satisfactory to the Sponsor and/or the Administrator may be required to verify eligibility. The Sponsor and the Administrator have the right to determine Sweepstakes eligibility in their discretion; all decisions concerning Sweepstakes eligibility are final. Any effort to circumvent the Sweepstake's limits, requirements, or other terms (including, but not limited to, providing fictitious information or concealing identity or location) voids submissions and disqualifies person from participating in the Sweepstakes.

By participating, Participants accept and agree to: (i) be bound by these Official Rules, any applicable rules, terms of entry, or terms and conditions related to any Prize elements (including, but not limited to, non-disclosure agreements as may be required), and all applicable laws and the decisions of the Sponsor, which shall be final and binding in all matters; (ii) waive any rights

to claim ambiguity with respect to the Official Rules; and (iii) waive all of his/her rights to bring any claim, action, or proceeding against any of the Released Parties for any Losses arising out of, or related to, this Sweepstakes. Should any portion of the Sweepstakes be, in the Sponsor's sole opinion, compromised by non-authorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play or submission of Sweepstakes Entries, the Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Sweepstakes. If terminated, at its discretion, the Sponsor reserves the right to select the potential Winners from all eligible, non-suspect Prize claims received prior to action taken or as otherwise deemed fair and appropriate by the Sponsor. In no event will the Released Parties be liable for more than the stated number of Prizes in these Official Rules. CAUTION: ANY ATTEMPT BY AN INDIVIDUAL TO DELIBERATELY DAMAGE THE WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO DISQUALIFY SUCH INDIVIDUAL AND SEEK ANY AND ALL REMEDIES AVAILABLE FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT PERMITTED BY LAW. Participants, by participating, agree that the Sponsor, the Administrator, Warner Bros., Keurig Green Mountain Inc., and each of their respective parents, affiliates, subsidiaries, advertising and Sweepstakes agencies, promotional partners, and all of their respective officers, directors, employees, shareholders, representatives and agents (collectively, "Released Parties") will have no liability whatsoever for, and shall be held harmless by Participants against, any Losses resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of a Prize (including any travel or activity related thereto) or participation in this Sweepstakes. **BINDING ARBITRATION:** Except where required by law, Participants and the Sponsor waive all rights to trial in any action or proceeding instituted in connection with these Official Rules or the Sweepstakes (including any activity related thereto). Any controversy or claim arising out of or relating to these Official Rules, or the Sweepstakes shall be exclusively settled by binding arbitration in accordance with the commercial arbitration rules of the American Arbitration Association, in Los Angeles County, California. Any such controversy or claim shall be arbitrated on an individual basis and shall not be consolidated in any arbitration with any claim or controversy of any other party.

**CHOICE OF LAW AND JURISDICTION:** All federal, state, and local laws and regulations apply. Void where prohibited by law. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any Participant and the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the state of California without giving effect to any choice of law or conflict of laws rules (whether of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than California. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these Official Rules not subject to arbitration shall be brought only in the courts of the State of California, in the County of Los Angeles. You hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non-conveniens or lack of personal jurisdiction.
